We like to keep all grooming and bathing supplies separate for each horse, so please bring the following items (clearly marked with the horse's name):

brushes, curry, hoof pick, fly spray, shampoo, sponge, sweat scraper, saddle pad(s). Saddle, girth, bridle(s), turn out boots (if required), cooler, sheet, blanket.

Remember to identify all items with permanent magic marker.

BOARDING RATES: All board includes stall cleaning, turnout (weather permitting), grain, hay, use of facilities, blanketing.

I would like **full monthly** training board at the rate of \$2,400 per month. Includes board for one month plus a minimum of 16 training sessions with Lynn (or owner) riding. Grooming for Lynn (**only**) included. Additional contiguous nights may be purchased for \$40/night. Additional training sessions (over 20) may be purchased for \$60/session.

I would like **partial monthly** training board at the rate of \$1,720 per month. Includes board for one month plus 8 training sessions with Lynn (or owner) riding. ** Grooming is **not** included. Additional contiguous nights may be purchased for \$40/night. Additional training sessions may be purchased for \$65/session.

I would like **weekly** training board at the rate of \$575 includes board for up to five (5) nights plus five (5) training sessions with Lynn (or owner) riding. **Grooming is **not** included. Additional contiguous nights may be purchased for \$40/night. Additional training sessions may be purchased for \$75/session.

I would like **weekend** training board at the rate of \$220 includes board for one (1) night plus two (2) training sessions with Lynn (or owner) riding. **Grooming is **not** included. Additional contiguous nights may be purchased for \$40/night. Additional training sessions may be purchased for \$90/session.

** If Lynn is scheduled to ride your horse, and you cannot be present to prepare horse before session, and take care of afterwards, and additional grooming fee of \$20 per ride will be assessed. Talk to Lynn about rates to have this service included in your board.
